# Privacy Policy

The Federation Burial Society collects and holds personal data on its members with the purpose of carrying out the objectives specified in its rules.

Personal data that is stored may be used for purposes including provision of pastoral care, administration of membership records, management of staff and volunteers and maintenance of its own accounts and records. The Federation's data processing also includes the use of CCTV systems for the prevention of crime.

The Federation is committed to ensuring information collected and used is appropriate for the purpose of providing member services and does not constitute an invasion of your privacy.

In order to fulfil those services that the Federation provides, it may from time to time pass on personal data to its service providers, who will be contractually obliged to store your details securely. Once their services are no longer required, they will dispose of the details in line with Federation procedures.

The Federation will not pass on your personal data to external third parties without first obtaining your consent, unless it is legally required to do so.

The Federation processes (collects, stores and uses) the information provided by its members in a manner compatible with data protection legislation. It endeavours to keep member data accurate and up to date and for no longer than necessary for business requirements.

The data provided by members is stored securely and subject to rigorous measures and procedures that minimise the risk of unauthorised access or disclosure.
